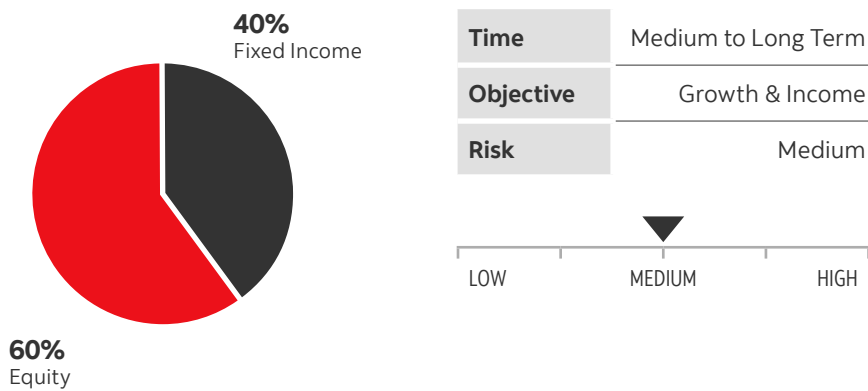


# Scotia Strategic Balanced Growth Portfolio

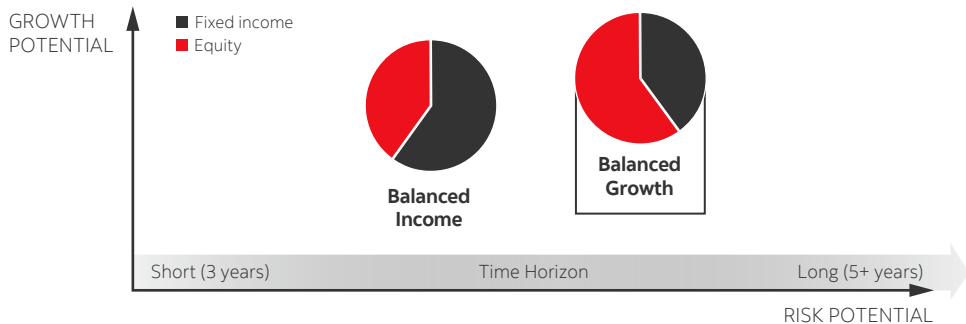
